PARENT VOLUNTEERS CHAPERONE STUDENT ACTIVITIES AND FIELD TRIPS, ASSIST WITH SPECIAL PROJECTS AND IN NUMEROUS FUND RAISING VENTURES, THEY MANAGE THE "PTF" (PARENT-TEACHER FELLOWSHIP), BOOSTERS, AND WORK IN THE DELI, TO NAME SOME OF THE MORE SIGNIFICANT VOLUNTEER SERVICE AREAS.

GIFTS BY DONORS WHO HAD NOT RESPONDED WITH THEIR DECISION, CONTINUE TO BE REPORTED AS NET ASSETS WITH DONOR RESTRICTIONS. AS A RESULT OF THE DECISION TO END THE CAMPAIGN, IN THE FISCAL YEAR ENDED 6/30/19, THE SCHOOL WROTE OFF \$2,208,151 OF PROJECT COSTS WHICH WERE RELATED TO THE DEVELOPMENT OF THE UNDERGROUND PARKING AND SHARED FIELD PORTION OF PHASE I, WHICH WAS TERMINATED. ADDITIONALLY, \$1,691,644 OF PLEDGES RECEIVABLE WERE FORGIVEN.
