Our 49 bed hospital provided patient and ancillary services to 2,525 inpatients and 133,287 outpatients during the 2018 tax year. The hospital provides emergency medical services regardless of ability to pay. Emergency medical services were provided to 15,887 individuals, and 1,788 of those individuals were admitted to the hospital. 4,054 surgical procedures were performed in the hospital during the tax year. The imaging department performed 45,663 procedures. 66,803 physical therapy 15-minute procedures were provided to area residents. During the 2018 tax year, free medical services in the amount of \$4,280,050 (gross charges) were provided to patients eligible for charity care.

Ancillary services for residents included 5,560 physical therapy treatments, while outpatients received 660 therapy treatments.

The hospital operates 11 family and specialty physician services clinics providing care in the following areas: Family Medicine, Pediatrics, Neurology, Surgery, Urology, Podiatry, Internal Medicine, Women's Health, Orthopedics, Oncology and outpatient substance abuse treatment. During the 2018 tax year physician and specialty services were provided for 28,519 visits.

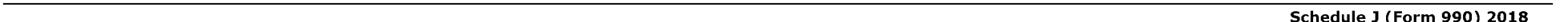

Other measures include Quality of Care indicators and Patient Satisfaction.
