Purchased ambulance supplies, paid for EMS training, purchased protective gear and paid for Workmans' Comp Insurance; community service -- purchased \$1,500 worth of fuel for Cantwell Community Center.

The fire service and ambulance service write checks for the expenses of their service and CCI is reimbursed by the grant
