LOCAL GROUP SUPPORT & CAPACITY BUILDING ROP worked with over 60 member groups across 31 of Oregon's 36 counties to build movement power for human dignity and justice in small town and rural Oregon. Staff logged thousands of miles, meeting with groups in communities across the state to develop local organizing plans that build local group power, respond to hate activity and advance a more safe and welcoming community for all. Over 140 organizers from 25 counties across rural and frontier Oregon convened in the spring in Cottage Grove for the 27th annual Rural Caucus and Strategy Session to make plans for our local organizing campaigns, such as hometown strategies to challenge detention and deportation, aligning local budgets with our values, expanding rural community media, and more. Our inaugural Rural Organizing Fellowship brought together and supported 10 leaders to expand the rural movement for justice in their own communities, meeting quarterly in communities around the state and leading projects in their own towns.

SAFE & WELCOMING COMMUNITIES Rural human dignity groups organized in their hometowns for a vision of safe and welcoming communities for all. Our organizing ranged from speaking out against "KKK" graffiti sprayed across town and organizing to shut down a neo-Nazi knife shop when it opened on Main Street. After it was exposed that Immigration and Customs Enforcement was holding parents separated from their children at the border in the Sheridan Federal Correctional Institute, we organized alongside local groups to hold rallies, send letters and advocate for the release of the asylum seekers and an end to the ICE contract. Along with leaders from Yamhill, Wasco, and Hood River Counties, we organized the March from Sheridan to NORCOR to raise awareness of the impact of the ICE contracts with FCI Sheridan and NORCOR, the Columbia Gorge's regional jail. Hundreds of rural Oregonians marched from Sheridan to NORCOR, having conversations about Ballot Measure 105 and the impact of local law enforcement collaborating with ICE.

CIVIC ENGAGEMENT Small town & rural Oregonians had thousands of conversations about the issues on the ballot in their communities. Groups across the state visited businesses, wrote letters, knocked on doors, made phone calls, held ballot parties, & more to defend Oregon's 30-year old sanctuary law that prevents the use of local, county or state resources for federal immigration policy enforcement. Local leaders delivered over 35,000 STAND Voter Guides with neighbor-to-neighbor conversations in all 36 counties. Rural Oregon showed up at the state legislature to pass policy that makes our communities safe & welcoming for all. We supported drivers' licenses for every Oregonian regardless of documentation status. We testified in support of paid family leave. We mobilized in every legislative district in the state, collecting thousands of postcards, making hundreds of phone calls & organizing dozens of in-person meetings. We engaged thousands of community members through gatherings such as "Drivers Licenses for All" & workshops such as "Demystifying Budgeting for Local Changemakers."
