School-age literacy programs reached into 7 school districts and across the community, engaging more than 120,000 children and teens in activities that cemented reading skills and academic success. Four primary investments last year: Books 2 U brought inspiring "booktalkers and take-home books to over 14,000 students in low-performing public schools. Summer Reading reached 112,000 babies, children and teens, including 97% of the county's elementary school students. In one of our highest-risk neighborhoods, the Rockwood Library Makerspace brought a hands-on, technology-rich learning environment and programs to nearly 3,000 teens. Welcome to Reading Literacy Kits and STEM Kits, reached thousands of children and parents at all library locations.

Form 990, Part III, Line 4b:

Early literacy programs reached 70,000 babies, young children and parents with books, parent education and programs that engaged families in reading together. For families at risk for low literacy, the programs help parents become their child's first, best and most permanent teacher. Every Child A Reader reached 33,000 young children and parents, sending books home weekly in 17 languages, educating parents, and motivating families to read together. The WIC partnership reached 21,000 high risk moms and children with literacy education at health clinics. Dia de los Ninos engaged 12,000 children and parents with bilingual literacy programs. The New Parent Program sent 4,000 newborns and parents home from the hospital with literacy education and a connection to the library.

Form 990, Part III, Line 4c:

Lifelong learning programs, workshops and events at library locations and outreach centers reached more than 22,000 people of all ages last year. Everybody Reads and the Teen Author Program reached students by bringing books, curriculum and discussion groups to 37 middle and high schools and youth organizations, transforming how students experience reading, writing, and the significance of the written word. Children and adults accessed free arts, cultural and humanities programs at branches across the system. Seniors and adults participated in the Everybody Reads community-wide reading program, including lectures and book discussion groups.
