School Programs Support We managed more than 220 designated accounts for service learning projects, homeless education program, bike education, special education, outdoor school, literacy mentors, high school career convention, graduation party, and many other programs relating to art, drama, extracurricular, foreign language, library, math, music, physical education, science, sports, technology, and robotics for the school district's 13 elementary, middle, and high schools that enrolled 6,733 students and employed 1,037 individuals, including 967 teachers and support staff, and an additional 70 coaches

Student Success Programs We supported an enriching education for all students, even those who were economically disadvantaged. Through our Student Opportunity for Success program (which was created to eliminate barriers to full participation in school for low-income students), we provided \$18,013 for financially needy students (benefitting 2,200 students) with art supplies, graphing calculators, take-home books for elementary school students, and non-standard school items such as backpacks and clothing, emergency health and hygiene supplies, food, snacks, field trip fees, music/athletic fees, extracurricular activity fees, and sleeping bags. We also provided rent money and transportation, in addition to the types of items mentioned above, for 210 homeless students, for a total of \$37,106. We also provided \$96,300 of grants through our intervention programs (benefitting 500 students) that provided summer and school-year academic support to students who are at risk of not graduating from high school. The summer programs served 464 students (over half were students in poverty and a significant number were students of color and/or second language learners) at the elementary, middle and high school levels, who attended enhancement courses in math, reading, writing, and study skills, and some students had the opportunity to visit colleges. Teacher Support Programs We awarded 20 learning enrichment grants to schools (benefitting 5,004 students) which provided \$40,481 for teachers' projects that enriched and enhanced the educational experience for students in the areas of animal husbandry, art, bilingual theater, community service, construction mathematics, cooking and nutrition, engineering, fitness, horticulture, music, science, technology, 3-D printing, yoga and mindfulness. We also awarded \$3,795 of grants for professional development training for 12 teachers, counselors and advisers. We provided \$5,000 for a school librarian to purchase books at the Guadalajara International Book Fair to build the Spanish library collections for the dual-language immersion programs at four schools. Through a new program called Sources of Strength, we provided \$12,673 for 20 teachers and staff to receive training in suicide prevention designed to harness the power of peer social networks to change unhealthy norms and culture. And through our Golden Apple Awards program, we awarded 4 stipends totaling \$3,060 to honor outstanding teachers and staff in the school district

We respectfully request the abatement of the late filing penalty due to reasonable cause. We have relied on our CPA to prepare and ensure that all required returns are timely filed for federal and state authorities, but she inadvertently forgot this one time to file an application for extension by the November 15, 2019 due date for the 2018 return. We generally extend the filing of Form 990 for 6 months until the next May 15 so there is sufficient time to prepare a complete and accurate return. Our CPA was personally experiencing an unusual amount of stress in her personal life during the time she would have normally filed Form 8868 to extend the filing deadline. In addition to providing accounting services for her nonprofit clients, she was in the process of selling a house and buying another house, and then her husband was laid off work on November 15. She ordinarily is diligent about meeting deadlines for her clients and regrets this oversight. She said this is the first time she has missed a filing or extension deadline during her 33-year public accounting career. On January 3, 2020, when it was discovered that Form 8868 was not filed by November 15, the executive director and finance committee took the immediate step of requesting that preparation and filing of the 2018 Form 990 be a priority. To our knowledge, the Foundation has filed all previous returns on time. To prevent this type of oversight in the future, we have put procedures in place so that multiple individuals will have reminders on their calendars about due dates for all federal and state returns.
