STATEMENT 1

THIS RETURN IS AMENDED DUE TO THE REPEAL OF SECTION 512(A)(7). WITH THIS RETROACTIVE REPEAL, THE ORGANIZATION HAS NO UNRELATED BUSINESS INCOME.

PART III, LINES 34 AND 36 ARE REDUCED FROM \$75,921 TO \$0 TO REMOVE EMPLOYEE COMMUTE BENEFITS.

PART IV, LINES 39 AND 44 ARE REDUCED TO \$0 TAX DUE.

PART V, LINE 50B IS INCREASED FROM \$3,050 TO \$15,815 TO REFLECT ADDITIONAL PAYMENTS MADE AFTER THE ORIGINAL FILING.

PART V, LINES 54 AND 55 ARE INCREASED TO \$15,815 TO CLAIM A REFUND OF OVERPAID TAX.
