With a total enrollment of 1,217 students, representing 42 states and 19 countries, the College provides instruction, research, public service, and academic support to 769 undergraduate and 448 graduate students. On the undergraduate side, students of color represent 63% of the class, with 56% of graduate students being students of color. Forty-three percent of undergraduates are first generation students. The College provides financial aid, scholarships, and fellowships to both our undergraduate and graduate populations. Ninety-four percent of undergraduate students receive financial aid, with the average award being \$25,645. Of the total \$19.2M in aid awarded, \$9.3M was funded by Mills. Thirty-three percent of our students receive Cal Grants and 52% are eligible for Pell grants. The College's undergraduate Hispanic population is 33%, making us eligible to declare as an Hispanic-serving institution (HSI). The percentage of graduate students receiving financial aid was 84%, with Mills providing \$2.0M in scholarships and grants and \$1.2M in assistantships out of a total of \$8.2M of any financial aid awarded to graduate students.

The College provides auxiliary services, including student housing, food services, and other student services. We are expanding our articulation agreements with local colleges and universities to make transferring to Mills more transparent and easier for students. In addition, we are defining potential partnerships at the curricular and resource sharing levels with a county wide community college system and a major research institution nearby campus. These arrangements would allow for cross registration and potentially dual admission between institutions.

There have been no related tax penalties or interest, which would be classified as tax expense in the statement of activities. The net operating loss carryover will begin to expire June 30, 2025 for federal purposes and June 30, 2019 for California purposes. The College applied ASC 740-10-25, Accounting for Uncertainty in Income Taxes, to all tax positions for which the statute of limitations remained open and determined there were no material unrecognized tax benefits as of the year ended June 30, 2019 and the year ended June 30, 2018, nor are any changes anticipated in the twelve months following June 30, 2019.</p>

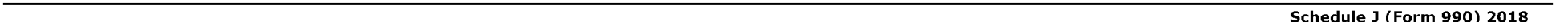
