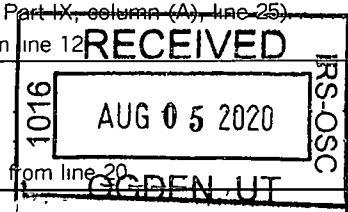

Artists-in-Schools:

The Workshop partners with public schools serving a majority of historically underrepresented youth: each year at least 80% of youth we serve are in low/lower-income families; 41% reporting are English learners, and 11% have Individualized Educational Plans. The youth in our classrooms bring a wealth of cultural and familial vales and traditions that are spoken to, nurtured and shared through the Workshop's unique critical thinking-based method. In 2017-2018, the Workshop conducted 254 residencies for youth in preschools and K-12 public schools in San Francisco, Marin, and Alameda Counties. External evaluations of our school-based residencies conclude that students in yearlong residencies show increased

Advocacy:

At Performing Arts Workshop, we believe that arts programs are an essential part of each child's education. We also believe that the arts make youth more innovative, creative, and better critical thinkers - which are vitally important skills for the 21st Century.

As a result, school districts, local and state government need to be held accountable for providing instruction in the arts. In 2008, Performing Arts Workshop launched its advocacy initiative to achieve this broader goal - beyond the bounds of what the Organization's direct service can provide.
