FOR THE LAST FOUR YEARS, WE HELD THIS EVENT TO RAISE FUNDS FOR CHILDREN IN NEED OF SCHOOL CLOTHES FOR THE UPCOMING SCHOOL YEAR. IN 2017 WE EXPANDED THE EVENT TO INCLUDE FUNDRAISING FOR BACKPACKS STUFFED WITH SCHOOL SUPPLIES IN CONCERT WITH NEW SCHOOL CLOTHING FOR MERCED COUNTY CHILDREN IN NEED AND HAVE SINCE THEN CONTINUED THIS PROGRAM. A MAJORITY OF THE FUNDS RAISED ARE GRANTED TO THE MERCED 20-30 CLUB WHO HOSTS THE CHILDREN'S SCHOOL CLOTHING SHOPPING SPREE OF WHICH WE ALSO PARTICIPATE IN (VOLUNTEERS). LAST YEAR THEY IDENTIFIED CHILDREN FROM DELHI ELEMENTARY SCHOOL DISTRICT IN MERCED COUNTY AS RECIPIENTS OF CLOTHING AND BACKPACK/SCHOOL SUPPLIES.
