Ross Valley Players (RVP) presents a main season of six major productions performed between July and June of the following calendar year. For fiscal year 7/1/18 thru 6/30/19 there were 20 performances of "The Savannah Sipping Society", 19 performances each of "The Odd Couple" and "Deathtrap", and 16 performances each of "Twelfth Night", "These Shining Lives", and "Moll Flanders". The total number of these performances were 106. The audience breakdown varies from one production to another based on the particular play, including such factors as play name recognition, the subject matter and content, whether the play is a classic or a new script, and whether the playwright is well known. The attendance for the six productions was about 7,575 plus 530 volunteer assignments. Audiences varied between 1660 for "Deathtrap" and 990 for "These Shining Lives". Ticket categories included general admission, subscribers, and greatly discounted prices for those under age 25. Additionally, two performances of "Love Letters" were performed as a fund raising event to benefit RVP's operations. About 60 patrons supported that event. All productions can include students in acting roles as well as in technician assignments. Having students and those under age 25 involved in productions helps RVP to accomplish an important part of its mission to provide an open, collaborative environment in which one can learn and develop theater crafts.

**Form 990, Part III, Line 4b:**

"The second largest activity is RVP's RAW (Ross Alternative Works) Festival. RAW's mission is to select and perform new works by SF Bay Area playwrights, to present staged readings of these works in order to provide audience feedback to the playwrights through talk back sessions, and to help them in refining their creations. In 2009, RVP decided to improve the presentation of such new works from a staged reading to a full production. This would include memorization of the script, building a stage set, actor direction and movement, costumes, stage lighting and sound effects. The intent is to provide audiences with a more complete presentation and to provide the playwright with the opportunity to see and hear a more complete production of his or her creative work. Finally, to receive the audience, director and actors feedback on multiple talk back sessions and to have the playwright ask questions of the audience. This fiscal year there was one full production of a new play "Scott & Zelda", that covered the life of author Scott Fitzgerald, his wife, Zelda, and his friends. The production had 10 performances and an audience of 868 plus 50 volunteer assignments. RAW often include students in both acting roles and in technical assignments. In addition, Raw had two staged reading of new play: "Swiss Family Robinson", "Anomalies" and "Trespassing" to provide audience feedback to their playwright. Total audience for "Scott & Zelda" and the three staged readings was about 1050 plus 70 volunteer assignments.
