Tobacco Programs - The San Bernardino County Tobacco Control Program works to reduce underage youth access to tobacco products and to limit secondhand and third hand smoke exposure in outdoor common areas and in health care facilities. In 2019, the program assisted two local communities in successfully passing local tobacco retail licensing policies in their respective jurisdictions, one of which restricted the sale of flavored tobacco products. Additionally, active tobacco education and outreach efforts were effective in engaging community members and partners in all regions of the County: the Mountain Region, Desert Region, and Valley Region. The Merced County Tobacco Control Program (MCTCP) is county wide tobacco control program dedicated to reduce secondhand smoke exposure and decrease use of flavored tobacco products among youth and residents in Merced County through policy, systems and environmental change. During 2019, MCTCP educated over 500 Merced County residents at community events and educational presentations, trained over 60 youth and adult volunteers to serve as tobacco control advocates, and educated local decision makers about policy options to reduce tobacco use and access to flavored tobacco products in communities across Merced County. In addition, MCTCP in collaboration with an alcohol use prevention program surveyed over 140 stores to identify how in-store product marketing influences consumption of unhealthy products. The Regional Advocates Countering Tobacco (ReACT) Program implements a tri-county tobacco control plan aimed at reducing and preventing tobacco use and decreasing exposure to secondhand smoke in Fresno, Tulare, and Kings County. During 2018-2019, the program provided tobacco control services to the communities of Hanford, Corcoran, Sanger, Orange Cove, Tulare, and Dinuba. As a result, the project provided over 60 leadership opportunities for youth in the form of weekly youth coalition meetings, trainings and youth engagement opportunities. In addition, ReACT welcomed 86 youth and 21 adults from seven counties throughout the Central Valley to participate in the annual Youth Leadership Summit, a 4 day summit that trains youth in leadership, tobacco prevention and advocacy. The Unidos Por Salud Project is a tobacco prevention program tasked with reducing tobacco-related health disparities among the Hispanic/Latino community in seven counties in the Central Valley (Kern, Kings, Tulare, Fresno, Madera, Mariposa, and Merced). In 2018-2019, the program trained over 50 youth to serve as tobacco control advocates throughout the Central Valley. With the help of their youth advocates, staff provided educational information on flavored and mentholated tobacco products and their negative health impacts, secondhand and third hand smoke, and how the tobacco industry targets Hispanic/Latinos to over 300 youth, community members, and elected officials and hosted a Hispanic/Latino Leadership Summit with 20 adult leaders from across the Central Valley. The Asian/Pacific Islander Partners and Advocate Countering Tobacco (API PACT) Program is tasked in reducing tobacco related health disparities and improving health equity among Asian/Pacific Islanders residing in the Central Valley (Fresno, Kern, Kings, Madera, Mariposa, Merced, and Tulare County). In 2018-2019, the program supported 1 API organization in adopting a comprehensive tobacco-free event policy which included restrictions to tobacco and electronic cigarette use. The program hosted 27 weekly meetings to train youth to serve as tobacco control youth advocates in their community with a total of 20 active youth coalition members. The program also hosted an annual API Central Valley Leadership Summit where 9 adult leaders were trained in building capacity and developing their skills to achieve health equity in the communities they served. The Smoke Free North State program educated over 500 adults residing in Oroville, CA on the dangers of flavored tobacco products and its volunteers were successful in getting an ordinance to ban the sale of flavored tobacco products in the city of Oroville on the Council agenda. The policy is expected to pass in early January 2020 and will be the first policy of its kind to pass in rural northern CA. The EQUITY project continues to recruit and train health care and behavioral health throughout Butte County; with a total of eight (8) collaborating partners exceeding the projects required five (5) required partners. The Si Se Puede project was active in Butte, Glenn and Tehama Counties this past year and was able to create Advisory Boards in all three jurisdictions and conduct a vaping forum for parents in Gridley, and butt litter pick up campaigns in Orland and Corning. Policy work from among several youth groups and the Advisory Boards will commence in summer 2019. The statewide Rural Coordinating Center was funded to start April 1, 2019. Staff were successfully recruited and hired and a subcontract for evaluation was procured in the first two months of the project. Likewise, the Gold Country Rural Regional program was also funded to start April 1, 2019 and was fully staffed and contracted employees in place in the first two months.

Form 990, Part III, Line 4b:

Cancer Programs - The Every Woman Counts program staff met and/or exceeded contractual activities with over 250 health education classes with approximately 2,500 participants, participated in over 200 community events, recruited / maintained conducted over 40 Community Health Workers and conducted follow-up with 100% of EWC eligible class participants to identify potential navigation cases. The clinical staff conducted over 100 site visits, orientations and trainings with providers and follow-up with EWC participants as referred by DHCS and/or Providers in order to increase early detection and treatments services. The Registry Services is a fee-for-service program that collects cancer data for over 35 facilities in California and submits it to the California Cancer Registry for inclusion in the statewide cancer registry. In 2019, over 2,000 cases were submitted for our facilities consistently meeting the accuracy rate of 97% or higher.

Form 990, Part III, Line 4c:

Medical Services - MSSP continued to provide strong case management, care coordination and advocacy for low-income seniors in Sacramento, Placer and Yolo Counties, collaborated with multiple community providers, and provided community out-reach.

Form 990, Part III, Line 4d: Other Program Services Description	OTHER PROGRAM SERVICES 4: Tobacco Programs - The San Bernardino County Tobacco Control Program works to reduce underage youth access to tobacco products and to limit secondhand and third hand smoke exposure in outdoor common areas and in health care facilities. In 2019, the program assisted two local communities in successfully passing local tobacco retail licensing policies in their respective jurisdictions, one of which restricted the sale of flavored tobacco products. Additionally, active tobacco education and outreach efforts were effective in engaging community members and partners in all regions of the County: the Mountain Region, Desert Region, and Valley Region. The Merced County Tobacco Control Program (MCTCP) is county wide tobacco control program dedicated to reduce secondhand smoke exposure and decrease use of flavored tobacco products among youth and residents in Merced County through policy, systems and environmental change. During 2019, MCTCP educated over 500 Merced County residents at community events and educational presentations, trained over 60 youth and adult volunteers to serve as tobacco control advocates, and educated local decision makers about policy options to reduce tobacco use and access to flavored tobacco products in communities across Merced County. In addition, MCTCP in collaboration with an alcohol use prevention program surveyed over 140 stores to identify how in-store product marketing influences consumption of unhealthy products. The Regional Advocates Countering Tobacco (ReACT) Program implements a tri-county tobacco control plan aimed at reducing and preventing tobacco use and decreasing exposure to secondhand smoke in Fresno, Tulare, and Kings County. During 2018-2019, the program provided tobacco control services to the communities of Hanford, Corcoran, Sanger, Orange Cove, Tulare, and Dinuba. As a result, the project provided over 60 leadership opportunities for youth in the form of weekly youth coalition meetings, trainings and youth engagement opportunities. In addition, ReACT welcomed 86 youth and 21 adults from seven counties throughout the Central Valley to participate in the annual Youth Leadership Summit, a 4 day summit that trains youth in leadership, tobacco prevention and advocacy. The Unidos Por Salud Project is a tobacco prevention program tasked with reducing tobacco-related health disparities among the Hispanic/Latino community in seven counties in the Central Valley (Kern, Kings, Tulare, Fresno, Madera, Mariposa, and Merced). In 2018-2019, the program trained over 50 youth to serve as tobacco control advocates throughout the Central Valley. With the help of their youth advocates, staff provided educational information on flavored and mentholated tobacco products and their negative health impacts, secondhand and third hand smoke, and how the tobacco industry targets Hispanic/ Latinos to over 300 youth, community members, and elected officials and hosted a Hispanic/ Latino Leadership Summit with

The Asian/Pacific Islander Partners and Advocate Countering Tobacco (API PACT) Program is tasked in reducing tobacco related health disparities and improving health equity among Asian/Pacific Islanders residing in the Central Valley (Fresno, Kern, Kings, Madera, Mariposa, Merced, and Tulare County). In 2018-2019, the program supported 1 API organization in adopting a comprehensive tobacco-free event policy which included restrictions to tobacco and electronic cigarette use. The program hosted 27 weekly meetings to train youth to serve as tobacco control youth advocates in their community with a total of 20 active youth coalition members. The program also hosted an annual API Central Valley Leadership Summit where 9 adult leaders were trained in building capacity and developing their skills to achieve health equity in the communities they served. The Smoke Free North State program educated over 500 adults residing in Oroville, CA on the dangers of flavored tobacco products and its volunteers were successful in getting an ordinance to ban the sale of flavored tobacco products in the city of Oroville on the Council agenda. The policy is expected to pass in early January 2020 and will be the first policy of its kind to pass in rural northern CA. The EQUITY project continues to recruit and train health care and behavioral health throughout Butte County; with a total of eight (8) collaborating partners exceeding the projects required five (5) required partners. The Si Se Puede project was active in Butte, Glenn and Tehama Counties this past year and was able to create Advisory Boards in all three jurisdictions and conduct a vaping forum for parents in Gridley, and butt litter pick up campaigns in Orland and Corning. Policy work from among several youth groups and the Advisory Boards will commence in summer 2019. The statewide Rural Coordinating Center was funded to start April 1, 2019. Staff were successfully recruited and hired and a subcontract for evaluation was procured in the first two months of the project. Likewise, the Gold Country Rural Regional program was also funded to start April 1, 2019 and was fully staffed and contracted employees in place in the first two months. OTHER PROGRAM SERVICES 5: The Performing Above the High (PATH) Project is a marijuana prevention program tasked with reducing marijuana use among 10-25 year olds in Fresno County. In 2018-2019, the program provided substance use prevention education to 14,791 Fresno County residents and nearly 600 youth were trained in an evidence-based comprehensive substance use prevention curriculum. OTHER PROGRAM SERVICES 6: Lock It Up Program - The Lock It Up Project (LIUP) is a community-based substance abuse prevention program designed to increase awareness of the risks and consequences with the illicit use of prescription and over the counter medication by teens and young adults ages 10-25 in Fresno County. This was achieved through a variety of campaigns geared to engaging program participants in educational activities inclusive but not limited to 452 activities. The activities provided to Fresno County residents were designated by population that included, college and elementary students, health professionals, law enforcement and community residents. Serving the entire Fresno County region, LIUP services were concentrated to 7 communities inclusive of the cities; Fresno, Firebaugh, Reedley, Kingsburg, Kerman, Sanger and Parlier. OTHER PROGRAM SERVICES 7: Medical Services - MSSP continued to provide strong case management, care coordination and advocacy for low-income seniors in Sacramento, Placer and Yolo Counties, collaborated with multiple community providers, and provided community out-reach. OTHER PROGRAM SERVICES 8: Other ProgramsThe California Personal Responsibility Education Program (CA PREP) is a teen pregnancy and STD prevention program serving the youth of Kings County with comprehensive adolescent reproductive health education. In 2018-2019, 349 youth were provided with comprehensive education on how to prevent unintended pregnancies and sexually transmitted infections. Additionally, the PREP program participated in multiple health and resource fairs distributing pregnancy and STI prevention information to youth at 5 high school campuses and 1 middle school site reaching a total of over 400 youth. In addition to youth, PREP staff provided information and education on Reproductive Health to over 50 adult women through a series of workshops at a Women's Recovery Home. PREP did not have an intern or volunteer during the 2018-2019 year.
