We offer clean, warm beds, meals, shower and laundry facilities, access to computers and telephones, and access to housing, health, and community services

Russell Street Residence - Russell Street Residence provides permanent supportive housing to 17 formerly homeless adults with severe and persistent mental illness (SMI). Our 24/7 services include meals, therapeutic activities, transportation to medical appointments, and assistance with daily activities. Staff also assesses residents who are able to move into a more independent setting, the Russell Street Annex, housing 4 adults with SMI. Annex residents live semi-independently and are responsible for the maintenance of their home, cooking, and cleaning. They continue to work with staff on developing and maintaining independent living skills
