In fiscal year 2019 the Food Pantry distributed 636,459 pounds of food to over 16,716 families or 54,694 individuals. The food distributed is a combination of government commodities, purchased food and donated food from the Food Bank of Alaska, retail stores, individuals and congregations. The LSSA Food Pantry is open four days a week.

LSSA also operates a Mobile Food Pantry every Tuesday in the parking lot of Lutheran Church of Hope. In FY2019 we distributed 271,607 pounds of food to 5,979 households or 18,475 individuals.

LSSA operates two housing units that benefit individuals that would otherwise be homeless.

Our Roosevelt House provides safe and affordable housing for low income female individuals with long term behavioral health issues and other medical problems. We served six full-time tenants in FY2019.

Our Transitional Living Program (TLP) provides assistance and transitional housing for single homeless men. Our goal of the program is to break the cycle of homelessness and help the residents find sustainable employment and thus sustainable housing. Clients are required to have a job or secure one in the first 30 days of occupancy and are required to be free of all substance abuse. Residents also are required to share in household chores and yard work. In FY 2019 we served 18 men.

4c (Code:) (Expenses \$ 93986 including grants of \$) (Revenue \$)**DIRECT ASSISTANCE**

LSSA's Direct Assistance Program covers three main areas. First is Neighbor-to-Neighbor, where we offer assistance to individuals who are looking for help obtaining a state ID, drivers license, birth certificate, clothing vouchers, bus passes and prescription care. Second area is with assistance with rides to and from medical or therapy appointments. Our third area helps with those who were medevacked into Anchorage for medical care. We provide assistance with housing, food and local transportation until they are released to return home. We then assist them with transportation home. In FY2019 we assisted 1,510 individuals with direct assistance funds.
