THE BERKELEY HIGH SCHOOL DEVELOPMENT GROUP (BHSDG) received and processed approximately \$613,000 in donations and other revenues during the 2018 2019 school year. Approximately 57% of this revenue (\$352,000) was directed to or earned by BHSDG to be distributed by our Board. From these unrestricted revenues, BHSDG provided funding for academic, artistic and club programs at Berkeley High School (BHS). Other BHSDG grants included: 1Teacher professional development, departmental retreats, teacher conferences and classroom support (\$26,000) 2Technology/ Equipment, including 92 Chromebooks and 220 Kindles (\$53,000) 3Field Trips/guest speakers, and student support (\$19,000). BHSDG received approximately \$261,000 in donations and other revenue earmarked for specific learning communities, programs and departments. BHSDG acts as a fiscal agent for these funds, at no cost, providing a significant benefit to BHS schools and programs. BHS schools and programs determine how they will spend these monies, and they were used for a wide range of educational enrichment opportunities. The BHSDG's fundraising and administrative expenses were \$46,000 for the school year (or ~7% of total expenses).
