Compensation paid to trustees was reasonable, and thus an excepted act as described in regulations section 53.4941(d)-3(c). Compensation for services provided by the trustees is reviewed and approved by the Superior Court of California, County of San Mateo. The total trustee compensation has been set at 0.9% of the fair market value of the assets of the foundation. After the Court's approval of compensation, the trustees review and allocate the total amount amongst the trustees based on experience and history with the foundation.

Line 1a(6) – Agreement to Pay a Government Official

Trustee John Violet is an elected official of a California municipality. His gross annual compensation from the municipality is less than the amount specified in Internal Revenue Code Section 4946(c)(5). Thus, payment by the foundation of reasonable trustee fees to John Violet does not constitute an act of self-dealing.
