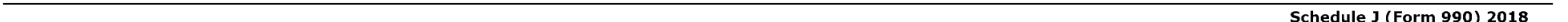

The board, through its policy manual and various adopted resolutions, has delegated specific levels of responsibility and authority to the university president in order to enable him and others at the university to make timely operational decisions. The president works with an administrative cabinet that has been hired by the president and approved by the board in carrying out his delegated responsibilities and in operating the university on a day to day basis. The administrative cabinet is composed of the university president, the vice president of finance and administration, the vice president for external relations, the vice president for spiritual development, the vice president for student development, the vice president for university advancement, and the provost. The only individual who also serves as a member of the governing body is the university president.
