IN 2018, SANTA BARBARA CITY COLLEGE SERVED AS A CRITICAL COMMUNITY RESOURCE THROUGHOUT THE THOMAS FIRE AND MONTECITO DEBRIS FLOW DISASTERS. THE FOUNDATION WORKED IN PARTNERSHIP WITH THE COLLEGE THROUGHOUT THESE DISASTERS AND THEIR AFTERMATH, MOBILIZING RESOURCES TO SUPPORT THE CAMPUS AND THE BROADER COMMUNITY. THE FOUNDATION RAISED AND DISTRIBUTED MORE THAN \$40,000 IN DIRECT AID TO MEMBERS OF THE CAMPUS COMMUNITY BETWEEN DECEMBER 2017 AND MAY 2018. IN ADDITION, THE FOUNDATION AGREED TO SERVE AS FISCAL AGENT FOR SEVERAL INNOVATIVE, VOLUNTEER-LED COMMUNITY RECOVERY EFFORTS INCLUDING THE SANTA BARBARA SUPPORT NETWORK, THE SANTA BARBARA BUCKET BRIGADE, AND THE 805 CONSERVATION COLLECTIVE. IN TOTAL, \$1,395,293 WAS RAISED FOR THESE EFFORTS THROUGH 2019. THE SANTA BARBARA BUCKET BRIGADE OBTAINED 501(C)(3) STATUS AND SEPARATED FROM THE SBCC FOUNDATION ON NOVEMBER 20, 2018. THE SANTA BARBARA SUPPORT NETWORK IS STILL CURRENTLY PURSUING INDEPENDENT 501(C)(3) STATUS, AND THE FOUNDATION ANTICIPATES TRANSFERRING ALL OF THE REMAINING ASSETS FOR THESE EFFORTS TO THE NEWLY FORMED ENTITIES DURING THE SUBSEQUENT YEAR. AS OF JUNE 30, 2019, NET ASSETS OF \$21,589 ARE INCLUDED AS A PAYABLE TO THE SANTA BARBARA SUPPORT NETWORK AND THE SANTA BARBARA BUCKET BRIGADE IN THE STATEMENT OF FINANCIAL POSITION.
