IDA's website is a vital portal into the industry that provides up-to-date information and opportunities to connect with the documentary film world. Pare Lorentz Documentary Fund provides production support for the creation of original independent documentary films that illuminate pressing issues in the United States. New York Community Trust has supported this fund since 2016 and in February of 2018 NYCT renewed their support with another grant of \$250,000, which is to be spent over multiple years. IDA awarded grants during 2018-2019 ranging from \$17,500 to \$20,000 to 4 film projects totaling \$95,000. Enterprise Journalism Fund provides research and development grants and production grants to documentary films that examine contemporary issue and use journalistic practice in the production of the films. The fund awards \$1 million in annual grants ranging from \$15,000 to \$100,000 as well as providing support and mentorship for filmmakers. IDA awarded grants during 2018-2019 ranging from \$15,000 to \$300,000 to thirty-one (31) film projects totaling approximately \$1,300,000.

More than 670 attendees had the opportunity to watch the films and meet the filmmakers and film subjects.
