AFTER RECEIVING NOTIFICATION OF A POTENTIAL CONFLICT OF INTEREST, THE BOARD OF TRUSTEES SHALL FIRST MEET AND DETERMINE WHETHER OR NOT THE ALLEGED CONFLICT EXISTS. NO TRUSTEE WHO, DIRECTLY OR INDIRECTLY, IS INVOLVED IN THE POTENTIAL CONFLICT OF INTEREST SHALL BE PRESENT DURING THIS MEETING. IN ADDITION, NO TRUSTEE SHALL BE COUNTED IN DETERMINING THE EXISTENCE OF A QUORUM AT ANY MEETING OF THE BOARD WHERE THE POTENTIAL CONFLICT OF INTEREST IS CONSIDERED NOR SHALL THE TRUSTEE VOTE ON ANY ACTION OF THE BOARD REGARDING THAT POTENTIAL CONFLICT. ALL PROCEEDINGS RELATED TO CONFLICTS OF INTEREST ARE DOCUMENTED IN THE MEETING MINUTES OR AS OTHERWISE APPROPRIATE.
