

Child Development/Early Education: Allies for Every Child ("Allies") early education programs, which leverage base funding from three California Department of Education contracts as well as two Early Head Start contracts, provide high-quality, year-round early education for more than 500 children ages 0 to 5 from very-low-income families. We provide services at our state-of-the-art early education center, through our network of licensed home-based education providers, and in individual family homes.

Allies maintains a low staff-to-child ratio in our inclusive, bilingual classrooms to ensure every child's healthy social-emotional, cognitive, and physical development. (See Sch. O)

4b (Code) (Expenses \$ 1,545,541. including grants of \$) (Revenue \$)

Child Welfare: Allies contracts with the Los Angeles County Department of Children and Family Services (DCFS) to provide Family Preservation and Prevention and Aftercare to more than 600 families annually. We work to prevent children from entering the foster care system by working with families to increase protective factors and protect children who have been (or are at risk of being) abused or neglected. Our highly-trained staff provide individual and family counseling, mental health services, extensive multidisciplinary case management, and host a robust calendar of supportive, inclusive family events to ward off the deleterious effects of social isolation.

Foster Care and Adoption (aka Resource Family Approval Services): Through Allies' Foster Care and Adoption program (also known as Resource Family Approval services), which is partially supported by a contract with the Los Angeles County DCFS, Allies carefully recruits, trains, and supports loving foster and adoptive parents who understand the deep and complex needs of children in the foster care system, and are committed to supporting the best outcomes for the child.
