WGH is a nonprofit 53-bed acute care hospital and 107-bed long-term care facility located in central Oahu. The hospital is the primary source of acute care hospital services for the civilian residents of its service area, which extends from central Oahu to the north shore, where it runs from Ka'ena Point to Waimea Bay. WGH is a small, rural hospital in the fringe area of a competitive metropolitan area. WGH faces many challenges to its continuing ability to provide top quality medical care to residents of its service area, including difficulties in attracting and retaining physicians and support personnel to staff the hospital. Randall M. Suzuki, M.D. is a licensed primary care physician in Hawaii and president of Haleiwa Family Clinic, Inc. ("Haleiwa Clinic"). At certain times, Dr. Suzuki has served on the board of WGH and/or WHA. Haleiwa Clinic is a Hawaii professional corporation that operates two physician clinics on Oahu. One physician clinic is located in Mililani, Hawaii. Haleiwa Clinic subleased the Mililani Clinic site from WHA. Haleiwa Clinic has sublet the Mililani office space from WHA since 2004. In recognition of financial difficulties faced by Haleiwa Clinic, WHA deferred payments of rent due. Over the years, the clinic accrued an outstanding balance for past-due rent. Thus, the facts here could be interpreted as WHA, in effect, loaning money to Haleiwa Clinic. However, the intent of WHA at all times was simply to assure the availability of much needed primary care services for residents of WGH's service area. Corrective action taken in August 2017, WHA's sublease with Haleiwa Clinic was terminated, and Haleiwa Clinic signed a promissory note, pursuant to which the Haleiwa Clinic agreed to repay the balance of the outstanding rent over a five-year-term with interest at the rate of 5% per year on the outstanding balance. The interest rate was 1-1/2 points over the prime rate as reported by the Wall Street Journal at the date of execution of the note. Dr. Randall Suzuki, the president of Haleiwa Clinic, personally guaranteed the note. Haleiwa Clinic continued to experience financial difficulty, and as of May 2019 was not current on payments under the 2017 note. WHA was still concerned about the availability of primary care for residents of the area, and therefore worked with Haleiwa Clinic to restructure the note. A loan modification agreement was signed, with an effective date of June 1, 2019. The principal amount due was not reduced, but the timing of payments was adjusted. Dr. Suzuki's personal guaranty remained in place. As of June 30, 2019, Haleiwa Clinic had made the payment that was due for the month of June 2019.
