The CWS Early Childhood programs built a strong foundation for later intellectual growth through our nursery, kindergartens and parent and tots/nature tots programs. The grade school programs provided a classical academic education utilizing an interdisciplinary, hands-on approach to learning. The high school program educated students based on the four cardinal virtues (wisdom, courage, justice, and temperance) and the intellectual virtues (liberal arts and sciences).
