28 During the 2018-19 school year, our three largest program services were assemblies (MCT/Science on Wheels), support of our leadership club with pass through money, and discretionary purchases including gifts to teachers. Each year, we try to provide a variety of ways to support our school. Our discretionary budget is a way to support things that arise year-to-year that may be unexpected or can be purchased once and benefit the school for years to come. This year we purchased a sound system to supplement the built-in systems that are provided in the commons and library. It has been used at assemblies as well as a glow dance, school play, and by the librarian. Additionally, the school district was in a transitional time between math curricula, and our fifth grade students (120) needed some supplementary math support. PTO provided software (Supplementary Math ALEKS) as well as Reading Take-Home Books that supported the students' learning as well as data collection for the teachers to understand their students' needs. In addition, every year the Orchard PTO puts on a silent action. The funds collected from this fundraiser are equally divided up between all the teachers at Orchard elementary for them to purchase supplies for their classroom.
