A MIXTURE OF 59 ADULTS AND CHILDREN PARTICIPATED IN THE RESPITE PROGRAM. THE HOURS ARE BEFORE AND AFTER PROGRAMMING, WHICH EQUATES TO 7:00 AM TO 9:00 AM AND FROM 3:00 PM TO 6:00 PM. THIS YEAR ROUND SERVICE ALLOWS PARENTS TO WORK AND PICK UP THEIR SONS/DAUGHTERS AT A CONVENIENT TIME. THIS IS A SAFE AND INTERACTIVE CARE PROGRAM THAT BENEFITS MORE THAN JUST THE FAMILY. IT HAS A POSITIVE IMPACT ON THE COMMUNITY, SINCE IT ALLOWS PARENTS TO CONTINUE TO BE EMPLOYED WHILE KNOWING THEIR LOVED ONE IS BEING SUPERVISED BY SPECIALIZED TRAINED STAFF.
