Tours/Retreats: Our youth choir went on tour to England, Ireland and Wales to compete in the Eisteddfod Festival. It was a very successful tour. Our three youth choirs participated in an overnight retreat in September; our 3 children's choirs participated in a half day retreat. The adult women's choir went on an overnight weekend retreat and our adult mixed choir participated in a day retreat.

4b (Code) (Expenses \$ **98,854.** including grants of \$ **3,785.**) (Revenue \$ **160,499.**)

Rehearsals: Rehearsals are the primary focus of the organization, providing music instruction to singers aged four through adult. Rehearsals allow our members to improve and hone their skills to become better musicians and singers, as well as to learn music in preparation for concerts, performances on tour, community outreach concerts, and other musical events in which we participate. Rehearsals teach the singers basic music skills, how to read music, music theory and sight-reading, and help the singers improve vocally as an individual, as well as a choir member.

Concerts: Performances help singers work toward goals, become more comfortable on stage, learn pre-performance routines and contribute their art to worthy causes while providing the community with free or inexpensive opportunities to enjoy music.
