Nature of loss - It was discovered in July 2020 that the treasurer had been misusing and embezzling funds from the organization since 2015.

Steps to recover the loss - On 7/11/2020 the individual was removed from the Board of Directors and the office of treasurer. Access to all of the financial accounts and accounting software of the Organization was terminated. The Organization has received significant restitution payments. The individual has agreed to make monthly payments until the remaining balance (as of October 31, 2020) of \$63,604 is paid along with accrued interest.

Procedures implemented to prevent re-occurrence - The Organization now has two separate Board members overseeing the finances of the Organization. Both board members have full access to all financial information. Going forward the board will require detailed profit and loss statements each month along with bank and other financial statements to back up the accounting. The finance committee will meet each month to be more accountable.
