The trust was set up to provide financial support to the libraries at the University of Iowa Children's Hospital, and the public schools of Wyoming, Iowa. The Midland Community School District is the administrative unit currently including these schools. Each receives 50 percent of the income of the trust. The trustee has always maintained a close and continuing relationship with the school district and the hospital library by exchanging mail and phone calls with the librarians at the libraries of the schools and their immediate superiors. After the end of each fiscal year on July 31, each librarian submits a report to the trustee detailing how the grant made for the previous year was used. The trustee reviews it, obtains answers to any questions he may have, and then issues a check for the next year grant to that library. This process has been in place for many years without problems.
