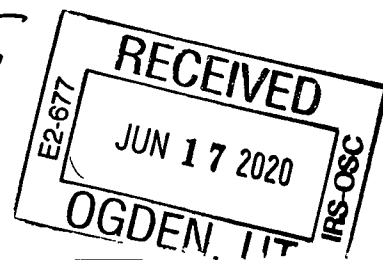

When a conflict of interest determination is referred to the Board, either following review by the Business Affairs Committee or if disclosure is made in the first instance to the Board (for example, when a trustee becomes aware of a possible conflict of interest during or just before a meeting of the Board) unless the trustee elects recusal, the Board shall decide whether a conflict of interest exists. The Board may question the interested trustee and the trustee shall have an opportunity to address to the Board whether there is a conflict. The interested
