During the planning stages, Wingspan works with school administrators to design each program for its corresponding grade level based on state and national standards, in addition to specific arts standards such as those outlined in The New York City Blueprint for the Arts. Wingspan Teaching Artists, in collaboration with classroom teachers, work with students in a variety of creative disciplines during their academic day. Residencies can range from 8 weeks to a full school year, and have served around 2,000 students each year.

In 18 years, the program has served more than 1,000 students and produced more than 61 productions. Wingspan Arts offers the only tuition-free, pre-professional theatre training program in New York City that culminates in full-scale productions. Students spend the summer acting, singing, and dancing while developing skills and friendships that will last them a lifetime.
