ESTABLISHED IN THE MID-70'S, THE ORGANIZATION INSPIRES AND MOBILIZES THE COMMUNITY TO INVEST IN ORGANIZATIONS AND LEADERS THAT WILL ADVANCE THE RIGHTS OF AND OPPORTUNITIES FOR WOMEN AND GIRLS, AND ACHIEVE GENDER EQUITY FOR ALL

FOR OVER 42 YEARS, WOMEN'S WAY HAS COURAGEOUSLY TAKEN POSITIONS ON CUTTING EDGE ISSUES RELATING TO WOMEN AND GIRLS. THE ORGANIZATION'S WORK HAS BEEN UNIQUELY STRATEGIC AND IMPACTFUL, ENGAGING AND CONVENING PEOPLE FROM ALL WALKS OF LIFE TO CREATE A TRULY COLLECTIVE AND "POWERFUL" VOICE FOR WOMEN. THE COMPLETED APPLICATION. IN FISCAL YEAR 2019, WE AWARDED NINE GRANTS TO ADDRESS URGENT NEEDS IN THE AREAS OF ECONOMIC SECURITY, HEALTH CARE ACCESS AND SAFETY/GENDER BASED VIOLENCE.

WOMEN'S ECONOMIC SECURITY INITIATIVE:

THE WOMEN'S ECONOMIC SECURITY INITIATIVE (WESI). WESI IS A SYSTEMS-LEVEL COLLABORTIVE INITIATIVE CENTERED AROUND THE SHARED VISION THAT ALL WOMEN IN THE PHILADELPHIA REGION ATTAIN FINANCIAL WELL-BEING FOR THEMSELVES AND THEIR FAMILIES. WESI BRINGS TOGETHER GOVERNMENT, NONPROFITS, PHILANTHROPY, BUSINESS AND WOMEN WITH THE LIVED EXPERIENCE OF ECONOMIC INSECURITY AROUND A COMMON AGENDA AND ALIGNED ACTIVITIES, USING THE COLLECTIVE IMPACT FRAMEWORK, THE WESI NETWORK IDENTIFIES CRITICAL SYSTEMIC GAPS, ENHANCES THE COORDINATION AND CAPACITY OF ORGANIZATIONS DOING PROMISING WORK, AND BUILDS A COMMUNITY COMMITTED TO DATA-DRIVEN LEARNING. AS THE BACKBONE OF THIS EFFORT, WOMEN'S WAY GUIDES VISION AND STRATEGY, SUPPORTS ALIGNED ACTIVITIES, BUILDS PUBLIC WILL, AND MOBILIZES FUNDING. SINCE ITS LAUNCH IN OCTOBER 2017, WESI HAS HELD 56 STAKEHOLDER MEETINGS AND ENGAGED OVER 144 PARTNERS. IN JUNE 2018, WESI COMPLETED THE FIRST YEAR OF ITS' PILOT FINANCIAL COACHING PROGRAM THAT INTEGRATES FINANCIAL COACHING INTO EARLY CARE AND EDUCATION (ECE) PROGRAMS THROUGHOUT THE PHILADELPHIA REGION. 178 CLIENTS AND 25 ECE CENTERS WERE SERVED. DURING FISCAL YEAR 2019, WOMEN'S WAY GRANTED A TOTAL OF \$150,000 TO TWO IMPLEMENTATION PARTNERS TO EXECUTE THE SECOND YEAR OF THE PILOT.

DONOR BASE. DURING FISCAL YEAR 2019, WE CONTINUED TO RESEARCH THE REGIONAL ECONOMIC SECURITY SYSTEM, WITH A SPECIFIC FOCUS OF CREATING A SYSTEMS MAP OF THE FINANCIAL SERVICES SECTOR. WE DETERMINED AND TRACKED PROCESS AND IMPACT METRICS FOR WESI, INCLUDING COMPLETING THE YEAR ONE ANNUAL REPORT OF THE FINANCIAL COACHING PILOT PROGRAM. THROUGH OUR MONTHLY CONVENINGS, WE TRACK LEARNINGS AMONG THE WESI PARTNERS, AND USE THESE LEARNINGS TO INFORM AND GUIDE STRATEGY. WE EVALUATED THE FINAL REPORTS OF SEVERAL IRAF GRANTEEES TO DETERMINE BREADTH AND DEPTH OF IMPACT. WE CONDUCTED AND COMPLETED AN EQUITY AUDIT OF WESI THAT LED TO THE CREATION OF AN EQUITY ACTION PLAN. WE ALSO CONTINUALLY CONDUCT PROSPECTIVE DONOR RESEARCH TO EXPAND OUR LIST OF INDIVIDUALS, CORPORATE AND FOUNDATION FUNDERS. OUR RESEARCH EFFORTS RESULTED IN EXPANDING OUR DONOR LIST BY 50%.
