In its tax year ending December 31, 2018, David W. Suitor, with his wife Linda McGorrill Suitor, who are both Trustees of the Timanous Foundation, sold to the Timanous Foundation real estate property located in Raymond, Maine on which the camp is operated. As part of this transaction, the Foundation has agreed to pay \$175,000 (\$8,333 per month for the first year and then \$6,250 thereafter) to the Suitors for consulting and management fees related to the operation of the property. As of August 31, 2019, the Suitors have received a total of \$91,667 from the Foundation to settle this liability. The contract has a remaining balance due of \$83,333. The Suitors were issued a 1099-Misc for the fees paid to them in 2018 and will receive one for payments to them in 2019.
