PASTORAL CARE: AT LUTHERAN INDIAN MINISTRIES WE PROCLAIM, DISCIPLE, AND HEAL. BUT OFTEN IN NATIVE MINISTRY, WE HAVE TO FLIP THAT SEQUENCE AND FOCUS ON THE HEALING FIRST. CHRISTIANS KNOW THE HEALING POWER OF THE GOSPEL AND HAVE MET PEOPLE WHOSE LIVES HAVE BEEN DRAMATICALLY CHANGED BY THE POWER OF THE HOLY SPIRIT. BUT IN MUCH OF INDIAN COUNTRY, THE HERO OF THE GOSPEL, JESUS CHRIST, HIMSELF, IS SEEN AS THE VILLAIN. FOR MORE THAN 500 YEARS, MISSIONARIES HAVE FORCE FED NATIVE PEOPLES FALSE TEACHINGS, THE GOSPEL MANIPULATED BY THOSE CLAIMING TO BE GOD'S WORKERS. THE CHALLENGE FOR OUR MINISTRY IS NOT THAT NATIVE AMERICANS DON'T KNOW JESUS. IT'S THAT THEY DON'T KNOW THE REAL JESUS. BECAUSE OF THIS, OUR STAFF MUST FIRST ASSIST IN THE HEALING OF THOSE ATROCITIES, SHOWING THEM THE TRUE LOVE OF CHRIST, BEFORE THEIR HEARTS

IN LAWRENCE, KS, LIM OPERATES A CAMPUS MINISTRY ADJACENT TO HASKELL INDIAN NATIONS UNIVERSITY.
