The MBG annually program service accomplishment is the hosting of the Midwest Basketball Showcase which was founded to allow youth under the age of 18 the opportunity to obtain college scholarships by showcasing their basketball talents in front of college basketball scouts. Our annual event is open to youth boys and girls and we do not discriminate against any youth, adult or team in the administration of the basketball tournament. In 2019, approximately 2,200 youth participated in the 3-day event which was played in front of college recruiters. The youth who played in the Midwest Basketball Showcase was a diverse group of youth including African American, Caucasian, Latino, Native American and Sudanese.

Part I, Line 2 The MBG provided grant assistance to the Omaha Crusaders to cover the hotel expenses incurred by their 17U and 16U youth basketball teams for tournaments they played in Birmingham, AL and Irvine, CA in July 2019. As a way of monitoring the use of its grant funds the MBG utilizes a policy and practice of making direct payments to the vendors, hotels, or airlines on behalf of the grant recipient as opposed to distributing grant funds directly to the grant recipient. In this case payments were made directly to the hotels.

Part III. The MBG as part of its mission provides assistance to youth basketball players who continue their education past college by enrolling in graduate school. Currently the MBG is providing assistance to 5 individuals who are either enrolled in law school or attempting to enroll in law school. The MBG provided grant assistance to 4 of the law students by purchasing their law books for their attendance at Drake Law School, Duncan Law School, Marquette Law School and Florida A& M Law School. The MBG provided grant assistance for a 5th individual to participate in the Kaplan LSAT review course in anticipation of enrolling in law school. All payments were made directly to the bookstores or other vendors who sold the books.

The MBG also provided grant assistance to a youth basketball coach to travel to youth basketball tournaments in Dallas, TX, Birmingham, AL and Irvine, CA with the payments made directly to the airlines.

It is critical that Nebraska youth have access to resources and chances to play in front of college scouts who might not otherwise discover a Nebraska youth player due to our sparse population in comparison to the majority of the U.S. The MBG further missions to support Nebraska youth athletes by providing educational support for those players who choose to further their education after college by enrolling in graduate school for a master's, law or medical degree. The MBG does not discriminate against any person based upon race, religion, national origin or sexual orientation and is proud that it has given aid to African American, Caucasian, Native American and Sudanese youth throughout its existence.

Part III-Line 4-Program Service Accomplishments: To further its mission, the Midwest Basketball group hosted its annual program service event, the Midwest Basketball Showcase ("MBS"). The MBS was created to allow Nebraska youth (boys & girls under age 18) to showcase their basketball talents in front of college scouts so that they could improve their chances of being awarded an athletic scholarship. The MBS is held annually in Omaha, NE and college scouts from Colorado, Iowa, Kansas, Minnesota, Missouri, Nebraska, North Dakota and South Dakota have attended in past years to scout the players at the MBS. The revenue is used to defray tournament related expenses for Nebraska youth teams to play in local tournaments like the MBS and to play regional & national exposure tournaments. In 2019, approximately 2,200 youth played in the MBS and over the years boys and girls who have played in the have received scholarships to over 35 different universities across the United States.
