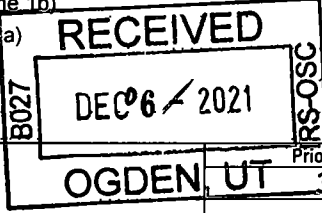

During the 2018 tax year, IAVMA entered into a distribution agreement (the "Agreement") with an organization (the "Organization") that provides revenue to IAVMA based upon amounts IAVMA members spend on the Organization's services and products (the "Referral Income"). The net income from the Agreement constitutes unrelated business taxable income ("UBTI"), which is being reported on its Form 990-T. When IAVMA entered into the Agreement, it was not aware that the income would constitute UBTI. As soon as IAVMA was made aware that the income was UBTI, it sought the advice of counsel in order to properly report the UBTI and ensure compliance with Treasury Regulations pertaining to unrelated trade or business activity and UBTI. IAVMA is now in the process of restructuring the Agreement so that it reduces or eliminates the incidence of UBTI.
