Part I Line 2	Grants were made in FY19 to start up chapters and for program expansion of chapters. Each prospective chapter must submit a detailed Chapter Application that addresses key factors that will ensure the success of each chapter and that each applicant has met all requirements, which include formation of a Core Leadership Team. Each grantee is required to report programmatic and financial results annually. The funds are monitored by oversight and assistance by the Chief Executive Officer of Project Transformation National. In addition, during FY19 Project Transformation National had Fiscal Sponsorship Agreements with certain chapters legally organized and operating but pending receipt of their separate exempt organization determination letter whereby National received charitable gifts, grants and contributions in support of the chapters, made acknowledgments to donors, and disbursed the funds in the form of grants to the chapters in accordance with the terms of the agreements. Project Transformation National retains oversight authority to ensure that the funds disbursed to the chapters are used for their intended charitable purposes, but the chapters' responsibility for the operation and conduct of the chapter programs. Grants reported include 32,880 received under fiscal sponsorship agreements and remitted to the chapters for the year ended August 31, 2019.
