ON FEBRUARY 27, 2020, THE CPA FIRM DISCOVERED THAT AN EXTENSION WAS NOT FILED FOR THE ORGANIZATION'S FORM 990 AS A RESULT OF AN ISOLATED INPUT ERROR THAT WAS ENTERED INTO THEIR DUE DATE TRACKING SYSTEM FOR EXTENSIONS. THE KEYPUNCH ERROR CHANGED THE STATUS OF THE FORM 990 FROM IN-PROGRESS TO COMPLETED STATUS AND REMOVED THE FORM 990 FROM THE LIST OF EXTENSIONS TO BE FILED. THEREFORE, THE EXTENSION WAS NOT PREPARED. THE CPA FIRM HAS PROCEDURES IN PLACE FOR REVIEW OF THE DUE DATE LIST OF EXTENSIONS FOR ACCURACY AND COMPLETENESS. HOWEVER, THE REVIEWER INADVERTENTLY DID NOT CATCH THE ERROR WHICH NORMALLY WOULD BE CAUGHT DURING THIS PROCESS.
