TIDE Swimming had an average of 550 swimmers enrolled across all programs during the 2018/2019 competition year. The Team achieved Silver Medal Club Recognition in USA Swimming's Club of Excellence Program. One swimmer qualified and participated in US Summer Nationals, 10 participated in US Summer Junior Nationals, 4 athletes qualified for US Olympic Trials, and 12 qualified for US Winter Junior Nationals. One athlete was selected for the US National Select Camp. TIDE also hosted 5 USA Swimming sanctioned meets with an athlete attendance between 500-775 athletes in each event.
