

SAF brings students and farmworkers together to learn about each other's lives, share resources and skills, improve conditions for farmworkers, and build diverse coalitions working for social change.

Into the Fields Internship & Fellowship - Twenty-four Into the Fields interns and fellows conducted outreach to over 5000 farmworkers in rural areas of the Carolinas. Through this immersion experience, the students worked with legal, health, education and organizing partners to inform workers of their rights, teach ESL, mentor migrant students and out-of-school youth, and conduct health education presentations on pesticide safety & occupational health & safety topics. They also coordinated a technology project providing computers and WIFI in four labor camps and facilitated participatory theater and documentary projects with migrant workers and youth. They shared their experiences with the larger public through blogs and presentations.

4b (Code ) (Expenses \$ 153,328 including grants of \$ 745 ) (Revenue \$ 3,269 )

From the Ground Up - SAF staff, interns, and alumni conducted presentations on issues ranging from child labor to food security. We organized events across the country for National Farmworker Awareness Week. We helped create a new exhibit about farmworkers and traveled exhibits to ECU and Johnston Health. We supported alumni to continue in the farmworker movement through peer support, mentoring, trainings, and professional development. We co-coordinated a number of community events, including Farmworker Institutes in both North and South Carolina.

Levante Leadership Institute - Ten core youth from Eastern NC participated in the Levante Leadership Program, engaging in trainings, retreats, and events focused on education and child labor. The youth received training in popular theater and co-created videos about pesticide safety, heat stress and mental health. We partnered with the Latino Community Credit Union to encourage saving for college and took the youth on a tour of Wake Forest University.

SAF selects scholarship recipients through a competitive application process and monitors their completion of the respective program requirements. Recipients receive a scholarship and verify in writing that they will use the scholarship to support their educational efforts.

**01. Form 990 governing body review (Part VI, line 11)**

Before the 990 is filed with the IRS, the executive committee reviews and recommends its approval to the full board. A complete copy of the Form 990 is provided to each voting member of the Board of Directors before its filing with the IRS.

**02. Conflict of interest policy compliance (Part VI, line 12c)**

When SAF contracts with individuals or organizations or hires individuals, management reviews the conflict of interest policy to ensure compliance. The Board signs an annual pledge which includes the conflict of interest policy.

**03. CEO, executive director, top management comp (Part VI, line 15a)**

The salaries of the executive director and the assistant director are determined by a pay schedule added to the organization's personnel policies after SAF's last union contract (8/31/16) negotiation. The Organizational Capacity Committee, which is made up of several Board and staff members, reviewed the schedule which mirrors the union contract in the way it determines initial salaries based on experience and annual pay raises. SAF has an additional policy that caps the top executive's salary to no more than twice that of the lowest paid employee. The full board approves changes in personnel policies as recommended by the OC committee. All other employees are covered by the three year union contract.

**04. Governing documents, etc, available to public (Part VI, line 19)**

SAF's financial information is included in its annual report, which is mailed to all donors and supporters and is posted on its website and listserve. Other documents are made available upon request. SAF makes its governing documents and conflict of interest policy to the general public upon request.
