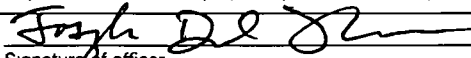

In addition to financial assistance, JWI develops a base of volunteers to serve as mentors to advise and encourage those in difficult economic circumstances in the hope that improved behavior patterns can be transformed and self-sufficiency can be established.

This aspect of JWI ministers to international students in our geographical area. Through this outreach to local campuses, JWI touches the lives of students from many countries. By assisting international students in navigating through the process of finding apartments and related household needs, Cross Culture Network connects with students in meaningful ways. The students are invited to join in dinner parties, trips and conferences that give opportunities to develop relationships and share the Gospel with them.

Ministering to the needs of the poor in Ethiopia has been a key program area for JWI for over a decade. During the fiscal year, JWI continued its partnership with the GAMBY Teaching General Hospital in Bahir Darm Ethiopia through the GAMBY Medical Mission. During this fifth year of ministry to the medical needs of the poor in the area of Bahir Dar, the GAMBY Medical Mission has provided surgical treatment and follow-up care for women afflicted the UVP or "Fallen Womb" and has funded cataract and goiter surgery for men and women. Joshua's Way also financially assists the ministry of the Beza Church in Addis Ababa, Ethiopia.
