A VOTING MEMBER CAN ALSO BE HELD BY A RETIRED AGRICULTURAL PERSON LIVING ON AN INCOME OR SOCIAL SECURITY ACCRUED AND NOT EMPLOYED FULL TIME IN ANOTHER OCCUPATION. A VOTING MEMBER CAN ALSO BE HELD BY A PARTNERSHIP OR CORPORATION RECEIVING THE MAJORITY OF INCOME FROM THE SALE OF AGRICULTURAL PRODUCTS.
