Access Denver, Colorado Leadership Alliance, Impact Denver, Leadership Alumni Network, Leadership Denver, Civic DNA, cDNA Fellows, Colorado Experience, B Civic, Prosper CO, and Mobility Choice are designed to prepare and connect leaders from the business and civic communities to strengthen Colorado's future. Access Denver exposes senior-level Denver executives to the influential people and critical issues of the Denver area, providing an exclusive two-day introduction to the city's business and community landscape. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenues of \$100,000 and expenses of \$47,268 for a program net of \$52,732. Colorado Experience is a two-day program designed to promote dialogue relating to statewide business and policy issues. The program provides an opportunity for emerging and executive leaders to explore Colorado's regional issues and to strengthen collective vision and collaboration in our communities. The program takes participants to a different city in Colorado each year. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenues of \$101,200 and expenses of \$112,956 for a program loss of (\$11,756). Impact Denver builds confidence and leadership skills for young professionals while introducing them to topics of significance to the region. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenue of \$290,590 and expenses of \$163,420 for a program net of \$124,170. Leadership Alumni Network ties together over 5,000 alumni of the Leadership Foundation's programs, who represent the Denver Metro region's business, civic, and community leaders. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenue of \$21,600 and expenses of \$74,160 for a program loss of (\$52,560). Leadership Denver is an 11-month program for active leaders focused on assuming civic leadership roles in the Denver Metro community. Leadership Denver is a balance of in-depth issues seminars, retreats, and a group community service project. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenues of \$290,008 and expenses of \$189,079 for a program net of \$100,929. Civic DNA represents inclusivity, collaboration, shared vision, and responsibility for today's leaders in Colorado. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenues of \$25,000 and expenses of \$32,785 for a program loss of (\$7,785). Civic DNA Fellows helps leaders with a deep commitment to Colorado to further develop their leadership skills so they can increase their business and civic impact. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenues of \$176,460 and expenses of \$150,041 for a program net of \$26,419. B Civic provides companies of all types and sizes the information, insight, and a network to learn more about how to be civic-minded while meeting business goals. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenues of \$160,971 and expenses of \$178,788 for a program loss of (\$17,817). Prosper Colorado is a nonpartisan research and communications project that works to identify the barriers preventing Coloradans from more fully accessing this economy, and pinpoint key strategies to ensure all Coloradans benefit from the state's economic success. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenues of \$155,000 and expenses of \$12,500 for a program net of \$142,500. Mobility Choice is working to maximize existing investments in the Colorado transportation system by leveraging technology to plan for future workforce and employer mobility needs, thereby increasing economic opportunities and quality of life. Inclusive of contributions made to the program in fiscal year 2019, this program generated total revenue of \$35,000. Program expenses totaled \$159,297 during 2019. Community partnerships program expenses totaled \$40,486. The Center for Financial Education (CFET) expenses totaled \$13,263 during 2019.

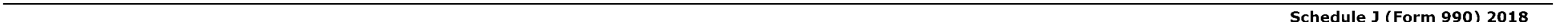
