Vineyard Early Childhood Center achieved the following: (1) maintained the rating of a "Four Star" quality center through Ohio's "Step Up to Quality" program, which recognizes excellence in early childhood education program. (2) The continued development of VECC includes using new and updating existing technology in the center, implementing new curriculum, and continued focus on professional development for the staff (3) maintained a 58% rate of enrollment of children from low to moderate income families (measured by eligibility for Title XX), reflecting continued diversity of families served; and (4) closed the half-day pre-school, academic year program and operated five all-day classrooms, for ages six weeks to five years and, against licensed capacity of 104 children per day, had average daily attendance of 74 children.

4b (Code:) (Expenses \$ 569,221 including grants of \$) (Revenue \$ 69,300)

The Organization's after-school and summer programming for school-age children is organized in grades K-5, known as "Vineyard After School" and "Vineyard Summer Program" respectively, and grades 6-12, known as "MSHS Vineyard After School". These programs achieved the following: (1) Further developed a partnership with Northland High School to serve an additional 38 youth for a day-time, in-school program led by the MSHS program manager. Overall enrollment for the MSHS Program increased from 40 to 82. The program also formalized the college and career readiness program with the addition of a full-time Directions Adviser. (2) Maintained partnerships with Future Ready and use of Learning Circles and DESSA tools for academic and social/emotional improvement (3) the Vineyard Summer Program offered 52 students (of the 120 served) 100% free summer services for up to 8 weeks and developed a partnership with Springhill Day Camps (a national summer camp program) to offer two weeks of camp activities in addition to the 6 week traditional program already offered. (3) The MSHS Program continued to offer summer employment for junior staff as well as offer programming, 3 days per week to rising youth in 6th-9th grades - 47 participants were served. (4) Overall - Vineyard Afterschool programming saw an increase in enrollment for services K-5 - 52 participants, 6th-12th - 44 participants for a total of 96 youth being served each week (does not include the in-school number referenced earlier).

The Organization's Sports & Exercise Programs saw a decrease in participation, from 2989 per month to 2244 per month (25% decline). Although we saw a decrease in youth sports participation, we did experience an increase in overall program offerings in sports and exercise activities. The average number of volunteers increased by 3, adding a new youth volleyball instructor, hip-hop fitness instructor, and health and wellness coach. Additionally, Vineyard Athletics extended its formal partnership with NOVA Village for AAU programming and launched 32 AAU basketball teams (10 more than last year), 320 athletes. The HS teams generated 18 college scholarships offers for its participants.

Form 990, Part III, Line 3: The Organization's One Child One Community mentoring program for school-age children was discontinued in June after its third year due to the end of its grant funding. It was established by grant funding through the Ohio Department of Education as a joint partnership between the Organization, Columbus City Schools, and Miles McClellan Construction. With decreased funding awarded in year three, program goals were adjusted and the staffing model changed. The program served over 300 students in eight Columbus City Elementary and Middle Schools. Throughout the duration of the program, One Child One Community engaged 270 mentors, 170 of them from Vineyard Church of Columbus and an additional 90 mentors from JP Morgan Chase. In addition to the in-school mentoring experience for the youth, field trips, special Saturday group mentoring sessions, winter clothing for participants, holiday meals for families, and participation in a school clean-up initiative were facilitated.

Form 990, Part III, Line 4d: The Organization's Social Outreach Programs (Expenses \$170,340) (Revenue \$60,420) achieved the following:

(1) Continued with a full time immigration attorney (pursuant to authorization granted in 2011 by the U.S. Department of Justice, Executive Office for Immigration Review, Board of Immigration Appeals), hosted community awareness events and trainings, and hired a paralegal to support the growing volume of clients served – 406 total; (2) average number of programs/classes offered increased to 45 class types per session with multiple offerings of each class type. (3) average attendance at classes and programs remained strong at 4526 (10% increase) (4) volunteers contributed more than 3000 hours in programming.

Form 990, Part III, Line 4d: The Organization's Free Health Clinics (Expenses \$100,199) (Revenue \$0.00) achieved the following:

(1) continued a partnership with Lower Lights Christian Health Clinic (FQHC) to utilize facilities at our two free clinic locations (Weinland Park community and VCC building). (2) The total patients served was 1,253 (3.2% decrease). (3) organized over 110 volunteers with total of 1,243 professional hours served and 1,694 clinic support hours served for a total of 2937 volunteer hours provided, and the conservative overall value of services rendered exceeds \$199K (an increase of 11% from the previous year).

Church of Columbus ("Vineyard Columbus"), whereby Vineyard Columbus provides to the Organization, on an exclusive basis, employees of Vineyard Columbus to fill the Organization's staffing needs. Form 990, Part VI, Line 7a-b: The Organization and Vineyard Columbus are related as follows: (1) the Organization is organized and operated exclusively to carry out the purposes and mission of Vineyard Columbus; (2) the Organization is controlled and managed by its Board of Directors, the members of which must be nominated by the Senior Pastor of Vineyard Columbus and confirmed by a majority of the members of Vineyard Columbus' "Coordinating Team" (i.e., its senior management team); and (3) the Organization's officers are elected by its Board of Directors, but the Organization's President must be either the Senior Pastor or the Executive Pastor of Vineyard Columbus.

Form 990, Part VI, Line 8b: The Organization answered "No" because it has no committees with authority to act on behalf of its governing body.

Form 990, Part VI, Line 11b: The Organization's Form 990 is prepared internally by the Organization's Executive Director (who is also the Organization's Treasurer), with outside professional support as necessary, after which the Organization's Board of Directors meets to review the prepared Form 990 prior to its filing. At the board meeting: (1) each board member is given a paper copy of the prepared Form 990; (2) any questions or concerns resulting from the board members' respective reviews of the Form 990 are discussed and resolved to the satisfaction of the board; (3) the Organization's Executive Director orally presents to the board a summary of the financial information presented on the Form 990 (it being the case that each board member is familiar with the Organization's financial statements and financial position in advance of the preparation of the Form 990); and (4) the Form 990 is not filed until any questions or concerns raised during the board meeting are resolved to the satisfaction of the board (even if such resolution requires subsequent meetings of the board).

Any covered person with a conflict of interest is prohibited from participating in any deliberation or decision as to any conflict of interest transaction.

Form 990, Part VI, Lines 15a and 15b: The process for determining compensation (as described below) is undertaken annually, following annual performance reviews (typically a mid-year event), and is used for all full-time positions of Vineyard Church of Columbus and the Organization, including the Organization's Executive Director. The process is as follows. Written annual performance appraisals are completed by the supervisor, in some cases with input from self-reviews and "360-degree" reviews by subordinates and key volunteers. All appraisals are reviewed, compared, and evaluated by a Salary Review Committee (the "SRC"), which is appointed by and under the jurisdiction of the Vineyard Columbus Church Council (i.e., its Board of Directors). The SRC is made up of Vineyard Columbus church members who are financially disinterested and independent of Vineyard Columbus staff, as required by Vineyard Columbus' code of regulations. The SRC's review includes the use of multiple national comparative salary reviews for churches (which are obtained by the Vineyard Columbus human resources department and provided to the SRC), with all positions classified into comparative salary ranges. Based on (1) a target average merit percentage established by Vineyard Columbus' Coordinating Team, (2) the employee's performance, and (3) the employee's current salary location within the predetermined salary range for the employee's position, the SRC, through a joint deliberative process that is contemporaneously substantiated in writing, determines and recommends adjustments for each employee. The SRC's recommendations are communicated in writing in the form of a spreadsheet that the SRC compiles over the course of its deliberations and gives to the Vineyard Columbus Senior Pastor, Executive Pastor, and human resources department. As required by Vineyard Columbus' Code of Regulations, the SRC's recommended adjustments are binding as to members of the Coordinating Team.
