Explanation: FEBRUARY 7, 2020 THE TAXPAYER'S CFO LEFT AND A CONTRACT CFO ASSUMED THE POSITION. AS PART OF THE TRANSITION IT WAS DETERMINED THAT THERE WERE UPDATES NEEDED TO UPDATE THE BOOKS AND RECORDS IN ORDER TO PROVIDE COMPLETE AND ACCURATE INFORMATION FOR THE FINANCIAL STATEMENT AUDIT. DURING THIS TIME THE TAXPAYER'S OFFICE WAS SHUT DOWN FOR AN EXTENDED AMOUNT OF TIME DUE TO COVID WHICH DELAYED THE PREPARATION OF DOCUMENTATION NEEDED FOR THE PREPARATION OF THE 2018 YEAR END AUDIT THAT WAS NEEDED FOR THE COMPLETION OF THE 2018 TAX RETURN. CLEARLY, THE LATE FILING WAS NOT DUE TO "WILLFUL NEGLECT." SEE, E.G., U.S. V. BOYLE, 469 U.S. 241 (1985) (DEFINING "WILLFUL NEGLECT" AS A "CONSCIOUS, INTENTIONAL FAILURE OR RECKLESS INDIFFERENCE"). RATHER, THE TAXPAYER CAN DEMONSTRATE "REASONABLE CAUSE" FOR THE UNTIMELY FILED RETURN IN THIS CASE, THEREBY QUALIFYING FOR ABATEMENT OF THE PENALTY. DURING THIS TIME POLICIES AND PROCEDURES HAVE BEEN REVIEWED AND UPDATED TO IMPROVE THE TIMING OF THE COMPLETION OF BOOKS AND RECORDS FOR YEAR END. THE TAXPAYER IS LOOKING FOR A FULL TIME CFO WITH EXPERIENCE IN GOVERNMENT FUNDING. THE HIRING OF A PERMANENT CFO WILL HELP WITH CONSISTENCY AND TIMING OF THE FINANCIAL STATEMENT INFORMATION NEEDED FOR THE TAX RETURN FILING. THESE STEPS INCLUDE ENGAGING A TOP 25 ACCOUNTING FIRM TO ACT AS ITS TAX PROFESSIONAL. IT IS OUR BELIEF THAT THE STAFFING TRANSITION AS WELL AS THE COVID SHUTDOWNS WERE THE PRIMARY CAUSES FOR THE DELAYS THAT RESULTED IN THE LATE FILING OF THE AUGUST 31, 2019 TAX RETURN.
