Because of its commitment to education of local students that will stay in the area, it has to date attracted gifts from individuals, corporations, and foundations with ties to the community. Through the Foundation's annual appeals, a broad constituency of approximately 2,700 potential donors is reached. (iii) Sources of Support The Foundation historically has received support from a broad representative number of foundations and individuals, rather than receiving almost all of its support from the members of a single family or small group of individuals. During fiscal year 2019, the Foundation received contributions from 82 unique donors. (iv) Representative Governing Body The Foundation's governing body is composed of 13 area civic and business leaders. The majority of the board members are not significant donors or disqualified persons. (v) Availability of Facilities or Services and Public Participation The Foundation's programs impact the students of the Galveston community and surrounding areas. During fiscal year 2019, a total of 344 students received financial assistance from the Foundation. See Form 990, Part III and Schedule I for details. CONCLUSION The Foundation believes it qualifies as a publicly supported charity described in IRC 509(a)(1) pursuant to the facts and circumstances test found in Treasury Regulation 1.170A-9(f)(3). The Foundation has and will continue to receive well in excess of ten percent (10%) of its total support from qualifying public sources. It serves all Galveston area high school students. Grantmaker's Description of How Grants are Used	During the year, Galveston College Foundation (GCF) notifies the Colleges Financial Aid (FA) office of the funds available for scholarships for the upcoming school year. The process of awarding scholarships is primarily done through the Financial Aid office: they prepare and disburse scholarship announcements, collect necessary documentation from the students, and also award the scholarships. For some scholarships, a special committee makes an award decision. Once all scholarships have been awarded and all of the FA process has been completed, scholarships are automatically applied to the students' account. This is handled at the College level; the Foundation is not involved in selecting students or applying scholarship funds to the student accounts. In certain instances at the request of the donors, Maria Tripovich works directly with the program directors to identify students in the program that are eligible for scholarships. These students are recommended by the program director, and Maria reviews key information (such as age, GPA, etc.) to ensure that the suggested students meet the donor terms.
