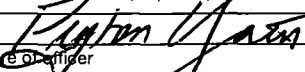

ARTESIA AQUATIC CENTER A private foundation was created to build an aquatic center for the City of Artesia and the Artesia Public Schools. Greater Artesia Foundation acted as a conduit of funds for those donors that were restricted to giving only to public charities. The Artesia Aquatic Center was completed and donated to the City/Schools in June 2019

MY NEIGHBORHOOD is a group of volunteers that have raised funds to create a Community Garden on an empty lot provided by the City of Artesia in an economically challenged neighborhood. My Neighborhood hopes to provide a sense of community ownership and stewardship while fostering the development of a community identity and spirit. Not only will this beautiful spot provide a common meeting spot to get to know neighbors, and, hopefully lead to crime prevention and community leadership in the residents, it will also provide these families the opportunity to grow fresh, healthy food for their families. This garden will also offer the opportunity for local schools to teach first hand lessons surrounding the agricultural arena, including where food comes from, math, economics, environmental responsibility and stewardship. With continuing additions and improvements every year, the garden now has 24 regular planter boxes with 5 handicap and 12 children's planter boxes nearly finished. This growing season, there were 35 regular gardeners with many more people stopping by to sit on the benches and just enjoy the beauty of the space. The number of organizations and volunteers working to improve and upkeep this community garden continues to grow, with local companies helping to keep the garden clean and weeded and the Downtown Lion's Club planting shrubs in the area outside the fence. This upcoming year will see the addition of a greenhouse for year-around gardening.

4c (Code _____) (Expenses \$ 42,792 including grants of \$ 13,720) (Revenue \$ 0)

RIDE FOR BIKES awarded to the children of southeastern New Mexico 602 bicycles. The bikes were given to the kindergarteners attending public schools in Tatum, Lovington, Hope and Artesia, New Mexico. Bikes were purchased using funds donated by companies and individuals and were assembled and delivered by 324 volunteers across the 4 towns. Ride for Bikes also provides scholarships to SE New Mexico high school graduates that have faced and overcome a challenge in their lives. The scholarship can be used for college or a trade school. Recipients are chosen by a nine-member volunteer committee that reviews the essays submitted by applying seniors. The committee makes their decisions based solely on the challenge of the student and the resilience displayed by the applying student to move forward. The scholarship is renewable for up to eight semesters, dependent on grades and attendance. Ride for Bikes holds one fund raiser each year geared toward promoting health through exercise. The No Sweat Just Wet is a walk run, bike or skate event during which local volunteers employ creative ways to get the participants soaking wet.

SENIOR SALUTE Exp \$31,151 Grants \$29,150 Revenue \$0

This event is an all-night lock-in that provides great food, decorations and games/activities to help high school seniors celebrate their graduation in a safe, alcohol and drug free environment. Approximately 50 parents volunteered to collect donations from local businesses and individuals, set-up and chaperone the event, and clean-up after the event. Decorations and games are re-used, leaving most of the money available for prizes for attending students. These prizes are used as incentive to draw seniors to this event and to keep them there over night as the prizes are given out at the end of the event (6 a.m.) and anyone leaving Senior Salute forfeits all winnings. Approximately 400 high school students were kept safe by this year's event, and gifts to the high school seniors totaled \$29,150 in prizes.

LIBRARIES AS LAUCHPADS Exp \$31,019 Grants \$0 Revenue \$0

Two private foundations, through Greater Artesia Foundation, are providing aid to the Artesia Public Library to bring to Artesia a boot-camp styled entrepreneurship program designed for aspiring entrepreneurs seeking to enter the market and gain traction or small early state businesses looking to grow. The program comes from Creative Startups, an international provider of entrepreneur training.

PACKS OF LOVE Exp \$30,866 Grants \$0 Revenue \$0

Provides sacks of easy-to-prepare foods weekly on Friday to school kids whose only meals are those provided at school. The students are recommended to the program by school counselors. Packs of Love also provides food bags and meat vouchers to the families of participants at Thanksgiving and Christmas.

MEMORIAL SCHOLARSHIPS Exp \$20,315 Grants \$20,315 Revenue \$0

GAF administers the funds for seven scholarship programs. For fiscal year-ended August 31, 2019, 34 Southeast New Mexico high school graduates received scholarship payments from these funds, including 18 new recipients from the 2019 graduating class. Each scholarship fund has a volunteer review committee that includes members of the school staff. These committees choose the recipients based on pre-set criteria created when the scholarship was funded. Students must provide their Acceptance Letter and class schedule initially and their grades for scholarships paid after their first semester. Scholarship checks are paid to and mailed directly to the college/university.

ARTESIA ARTS COUNCIL Exp \$15,702 Grants \$15,702 Revenue \$0

Greater Artesia Foundation provided funding for renovations/upgrades for the Artesia Arts Council offices and for the Ocotillo Theater on a reimbursement basis. Artesia Arts Council submitted receipts for reimbursment during FYE 8 31 19 for adding power to stage, repairing a wall in the ticket booth, repairing the outside emergency lights and purchase of a digital console & door hardware.
