To that end, we understand that this policy is not meant to supplement good judgment and all constituents should respect its spirit as well as its wording. In addition, any member of United Way of Eddy County's Board of Directors or Staff shall refrain from obtaining any list of clients or donors for personal or private solicitation purposes at any time during the term of their affiliation.
