GRANTS IN ISRAEL The grants made to the Hand in Hand organization in Israel enabled the creation of new bilingual and multicultural learning programs in 12 preschools in the city of Tel Aviv, and supported the growth of the existing six Hand in Hand schools in Israel. During the 2018-2019 year, Jewish and Arab student enrollment grew by over 10%. In addition, plans were laid for the establishment of a 7th school in the twin Israeli towns of Rosh Ha'Ayin-Kfar Kassim, due to open in September 2020.
