THE INSTITUTE HELPS SUPPORT THESE CENTERS THROUGH A MONTHLY PLEDGE TO NYINGMA CENTERS, AND MONITORS THEIR PROGRAM ACCOMPLISHMENTS AND USE OF FUNDS THROUGH REGULAR REPORTS AND AN ANNUAL WEEK-LONG MEETING THAT TAKES PLACE IN JULY, ATTENDED BY REPRESENTATIVES OF THE NYINGMA INSTITUTE, NYINGMA CENTERS, AND EACH FOREIGN EDUCATIONAL CENTER.
