It has training for all ages, from recreational and pre-professional youth programs serving students as young as 6 years old, to recreational adult classes and private lessons. It also offers full-time professional training for aspiring physical comedians through the Clown Conservatory program, which graduated 11 students this year. In addition, Circus Center offers artist residencies; summer camp; corporate, youth, and group events; workshops; specialty intensives; and much more. The Center also produces five semi-professional shows annually: two performed by the trainees in its Clown Conservatory professional training program; two performed by professionals and advanced adult students; and one performed by the San Francisco Youth Circus, its pre-professional youth training program. Collectively these performances serve thousands of audience members every year, all at accessible ticket prices.
